- (3) The minor willingly lives separate and apart from parents or guardian, with or without the consent of the parents or guardian, and that the minor is managing his or her own financial affairs, regardless of the source of any lawful income.
- (4) For good cause shown, it is in the best interests of the minor, any child of the minor, or the parents or guardian of the minor.
